REGULATIONS of participation in the Scientific and Technical Conference entitled: "Modern Technologies in Industry"

§ 1

Introductory information

- 1. § 2

Terms and Conditions

- 3. After the verification of applications, confirmations of participation in the conference will be sent by e-mail
- 4. The Organizer has the right to change the form of the speech at the Conference and to inform the Participants about this fact in advance.

§ 3

Share

- 1. For each submitted paper or poster, the participant has the right to publish it in the conference materials.
- 2. Each participant has the right to publish a maximum of two papers that meet the "Editorial Requirements" in Monographs published by the Scientific Publishing House of the Jacob of Paradies

- Academy in Gorzów Wielkopolski (http://www.wydawnictwo.ajp.edu.pl/). The organizing committee has the right to increase the number of papers after prior agreement with the author(s).
- 3. Each participant of the Conference will receive information by e-mail about the conference and the publication of the paper.

§ 4

Publication of papers in Conference Proceedings and Monographs

- 1. When preparing a paper for publication in "Monographs", one should be guided by the "Editorial Requirements" specified on the website: http://technologieprzyszlosci.ajp.edu.pl/
- 2. In accordance with the Ordinance 1/0101/2021 of the Rector of the Jacob of Paradies University in Gorzów Wielkopolski of 28 January 2021, a person who is not employed at AJP and intends to publish his or her work in a monograph published in the AJP Scientific Publishing House, pays a fee of **PLN 250** for the material submitted for printing.
- 3. Pursuant to § 4 point 2, if there are more authors in the publication, including an employee or student associated with the Jacob of Paradies University in Gorzów Wielkopolski, the fee should be reduced by his or her share.
- 4. The condition for publishing the papers in "Monographs" is to meet the "Editorial Requirements", send the "Declaration on the transfer of copyrights" in the form of a scan to the **konferencja.ntp@ajp.edu.pl** address mailto:konferencja.swb@gmail.com and pay the fees in accordance with § 4 point 2.
- 5. We reserve the right to make corrections and correct errors in the submitted papers, without the need to inform the authors of these corrections.

- 7. Failure to comply with the deadlines specified in the Conference Announcements sent to the participants may result in the paper not being accepted for publication.

§ 5

Personal Data Controller
